EVOTAN (CHESTNUT EXTRACT)

This is a natural additive for animal feed obtained from selected chestnut wood extract (*Castanea sativa* Mill.) with water. The entire process follows a very strict HACCP system. A natural anti-oxidant, which protects the gastro-intestinal mucous membrane.

ORGANOLEPTIC CHARACTERISTICS

Apperance: amorphous powder or granules.
